EXPLANATION OF TRUST FUNDS AND SPECIAL FUNDS

- **Susan D. Phillips Memorial Fund:** To provide a Best of Breed trophy at the National Specialty, and also special awards which are given at the yearly awards ceremony. Also in any calendar year to grant an award, or awards to the person(s), association(s) and/or corporation(s) whose work and efforts are deemed to have been of outstanding quality and benefit to the NEAA, the Norwegian Elkhound, and/or dogs in general.
- **Miriam Phillips Educational Fund:** To grant an award or awards to person(s), association(s), and/or corporation(s) whose work and efforts are deemed by NEAA to be of outstanding educational value and benefit to the NEAA, the Norwegian Elkhound, and/or dogs in general.
- **Ed Schlesinger Memorial Fund:** To provide a yearly outstanding service award to the person(s) whose work and efforts have been of outstanding quality and benefit to the NEAA and/or the Norwegian Elkhound breed.
- **Wells and Catherine S. Peck Memorial Fund:** Awarded on even number years to the person(s) whose work and efforts are deemed by NEAA to have been of outstanding quality and benefit to the Norwegian Elkhound.
- **NEAA Donor Advised Fund:** Designed to provide financial assistance in funding specific health research on the Norwegian Elkhound, or specific diseases, and may be withdrawn only for purposes of canine health research or canine health education. Administered by the AKC Canine Health Foundation, an IRS 501(c)(3) organization, donations are charitable tax deductions.
